ENTERTAINMENT INDUSTRY RENTAL POLICY

SECURITY DEPOSITS

1. Security deposits are fully refundable when the item comes back on time, undamaged, and otherwise in similar condition as when it left our studio.
2. The deposit shall be equal to the purchase price (replacement) value.
3. Rentals for items valued at \$5000 or more require a Certificate of Insurance that covers loss and damage, deposit will equal the deductible.
4. International rentals provide full replacement value as a deposit.
5. Deposits can be made using any method mentioned in "PAYMENT METHODS".
6. Credit card deposits will be authorized, with all holds dropped upon successful completion of the rental.
7. If the rented item is out longer than already paid for, the credit card will be charged for the additional costs.
8. If your rental is to be longer than your contracted days, the full, longer rental amount will be charged.



VALID IDENTIFICATION IS REQUIRED FOR ALL RENTALS

PAYMENT METHODS



1. Accepted: Cash, VISA, MasterCard, American Express, and PayPal for all rentals.
2. Not accepted: Personal Checks
3. All rental fees are payable upon rental.
4. Work on your order starts upon acceptance of payment by AMI.
5. A Credit Card Authorization form signed by the credit card holder must be on file for all CC payments.



CLEANING FEE

1. A cleaning fee of 10% of the rental amount total is charged on all costume rentals.
2. If the item is soiled or damaged beyond economical repair, you will be charged the "VALUE" of that item.

LABOR FEE



1. There is a \$75/hr labor fee required for an in-house tech to do research, send additional photos, pull stock for a presentation, prep for show & tell meetings, etc. Minimum charge is one hour.
2. Fee is due regardless of rental.

TERMS & DEFINITIONS



1. 1 Day Rental consists of 24 hours, or part thereof;
2. 3 Day Rental consists of 72 hours, or part thereof;
3. 1 Week Rental consists of 7 contiguous days, or part thereof;
4. 2 Week Rental consists of 14 contiguous days, or part thereof;
5. All Rentals are "As Is".
6. "As Is" refers to the exact condition of the item as shown in the online store;
7. All sales are final. Canceled rentals subject to a 20% fee.
8. No stock photo or video creation without written approval by AMI.

FITTINGS & TRYOUTS



1. Costumes can be dressed onto actors that are trying out.
2. Prices are \$750/4 hours, \$1500 for 8 hours. Price includes an experienced costumer, changing rooms, dressing area, large presentation area, convenient parking, wireless connectivity and a meeting room (at client's request).

COSTUME & PUPPET MEDIA USAGE



1. Rental amount includes a single media use, for a single publisher
2. Additional media uses are charged at 75% of original rental
3. If additional usage is not revealed, but instead, is discovered by AMI, then that additional usage will be charged at 150% of original rental amount.
4. Individual media uses include: broadcast, internet video, print media, print advertising, labeling, merchandising, 3D media, and others.
